#### I. ADMINISTRATIVE BUSINESS

- 1. Call to Order Kyla Mallett, Chair, called the meeting to order at 9:36 a.m.

that the Senate Budget Committee discussion could be taken up then and with members of the Finance team and the Senate Chair present.

A friendly amendment was accepted to add both items for discussion only.

#### II. BUSINESS

1. Vice President Academic + Provost's Report

Natasha Himer provided updates on behalf of the President and Provost.

- N. Himer announced K. Mallett's appointment as the new Provost at NSCAD and offered congratulations on behalf of ECU.
- K. Mallett was recognized for 23 years of service, her co-leadership in strategic planning, significant contributions to curricular development, and efforts in building community partnerships. Multiple Senators expressed appreciation for her collegiality and leadership.
- N. Himer also welcomed Gabriel Liosis as the new Senate Administrative Coordinator and a round of introductions was facilitated by the acting Chair.
- 2. INFORMATION: Convocation and Grad Show

Convocation will take place on May 8 with two ceremonies to accommodate the large cohort. Senators were encouraged to RSVP to participate as part of the platform party.

The Grad Show will feature work from 324 students. Mark Johnsen shared highlights of the important work and planning efforts underway.

3. INFORMATION: Academic Planning + Priorities Committee Report

#### 6. DISCUSSION: Senate Budget Committee

A detailed and lengthy discussion was held regarding the functioning of the Senate Budget Committee, prompted by a motion brought forward by Alex Phillips.

The following is a summary of reflections and opportunities for improvement that were expressed regarding the Senate Budget Committee and the recent discussion and presentation on the budget:

- Many Senators would like more time to review financial documents, where possible.
- Some Senators would like more detail and/or explanatory notes to financial information. An example given was the "Other" category.

- Some Senators would welcome more visual presentation of information; it was felt that could make the information more accessible
- Many Senators feel that they would benefit from more financial training and that this
  would enable Senators to provide more meaningful input and/or ask questions in
  Senate Budget Committee discussions. Some Senators would like more clarity on the
  role of Senate. While many understand the advisory role of Senate, they would like to
  better understand the academic implications of budget decisions—how budgetary
  allocations affect teaching quality, research capacity, and student support services—
  rather than micro-managing operational line items.
- Some Senators raised further thoughts on the issue of accessibility and echoed that
  they would like to see more visual representation of information and made
  suggestions such as glossary handouts, annotated visual aids.
- May Senators are interested in how they can provide alternate recommendations before budgets are passed to the Board of Governors.

N. Himer confirmed that the May Senate meeting would include a dedicated segment for discussion the Senate Budget Committee practices, with participation from the Finance team. Additionally, the Senate Governance Committee is currently reviewing practices across peer institutions and to identify potential recommendations on Senate Budget Committee composition, training, and processes.

7. DISCUSSION: Section 27(2)(r) of the University Act

Senator Phillips introduced the topic, referencing the following provision under subsection 27(2)(r) of the University Act. The provision was shown on screen for all Senators and is excerpted below.

#### Powers of board

(2) Without limiting subsection (1) or the general powers conferred on the board by this Act, the board has the following powers:

(r) with the approval of the senate, to determine the number of students that may in the opinion of the board, having regard to the resources available, be accommodated in the university or in any faculty of it, and to make rules considered advisable for limiting the admission or accommodation of students to the number so determined[.]

Senators Phillips noted that it is not clear how this statutory provision has been interpreted and implemented at ECU. A few Senators offered their interpretations of the provision.

In response, Kathryn Verkerk explained that this area is on the radar of the administration and ECU's historical practices are being reviewed. She shared that developing an admissions policy has been prioritized; there is active work underway on enrollment management strategies; this area and Senate's engagement with regards to enrolment has been identified for review and conversation with the Academic Planning and Priorities (APP) committee of Senate.

Senators were responsive to hearing that there will be policy and process development in this area. A few Senators made note of their particular interest in seeing that there is a balancing of resources/resource constraints with any potential institutional growth, consideration for infrastructure capacity, and program-level impacts.

N. Himer also contextualized this issue as part of broader policy work needed at the institution, again with reference to recent policy work such as on program review and on admissions, as noted by the Registrar.

#### **Chair's Summary:**

- 1) CPR Course Change Form Working Group handover Kyla Mallett gave an update on the status of the CPR Course Change Form Working Group's work to date. The CPR Committee needs to check in with the already established working group to see if they want to continue or if other members would like to take over. The working group is currently revising the new course form and hasn't begun work on the course change form yet. Many consultations have already taken place, and a group has spoken to the DQAB regarding their new requirements for course and program changes. The working group needs to consider operational impacts of program changes and impacts on admissions. The forms should include a checkbox and information on research requirements. There are notes left in the draft of the new course form regarding the two questions on decolonization and climate change. More consultation and broader considerations are needed around the two questions. Alternatively, the questions could be embedded with the learning objectives. The finished forms should be fillable PDFs.
- Kyla Mallett presented 2 course change proposals: DRWG 208 Drawing: Studio Material & Techniques and DRWG 218 Drawing Studio: Process/Transformation which were approved unanimously with a couple friendly amendments.
- Jacqueline Turner presented a course change proposal for FNDT 115 Indigenous Presence/Locating Ourselves in Place which was approved unanimously with a couple friendly amendments.
- 4) Under Other Business, there were updates and discussions on the following topics:

#### Agenda Planning meetings for CPR next Senate cycle (update)

Agenda planning meetings to set CPR agendas will be added to the Senate schedule. Stricter timelines will be needed. The meetings could be added to the timeline when course changes go to the CPR Prep group.

#### Curriculum/course change – setting a schedule with Senate (discussion)

Emily Carr doesn't have an academic calendar. Student Services is currently researching software to help with its production. An academic calendar helps predict the schedule for the year and helps keep Student Services, Scheduling, and students on track with less confusion. Once we have an academic calendar, course and other curricular changes will have to follow a stricter schedule of when changes need to go through Senate as the calendar is only published once a year.

**July course registration change (update) –** Fall registration is shifting from June to July. This gives more time to prepare for registration and to make more offers to faculty before registration opens.

**DQAB** (update) – Diyan went to a sector meeting for colleges – all are concerned about the new DQAB guidelines. We need to do the tracking of our courses and programs and the DQAB will attempt to make the guidelines clearer. In terms of new programs, we need to look at how we embed questions around financial impacts, and resource and space requirements, and to have our own guidelines for these things as well as enrolment plans and a flow of students into those programs.

**Policy work – review of Policy 4.16 (update/discussion)** – The Assessment and Academic Standing Policy which includes the grading matrix, grading policy, and academic standing policy hasn't been reviewed since 2015. The bulk of this policy is on all the course outlines. Kathryn Verkerk is researching what other institutions have in their policies. Policies will be reviewed over the next year with a focus on foundational policies first. Clarity is needed between grad and undergrad policies.

#### **Current Course Description:**

This course provides students with focused studio time to explore perceptual and conceptual approaches to drawing. Using a variety of materials, tools and techniques, students will explore observation-based methods to build hand-eye coordination. Experimental and process-related approaches to drawing will be incorporated to expand students' understanding of what a drawing can be. Activities include working from the life model, collaborative exercises, and engaging in historical and contemporary research. Discussions and individual/group critiques develop critical and analytical skills. The curriculum will be supplemented with a variety of approaches that may include readings, artist presentations, and field trips. DRWG 208 and 218 can be taken in any order.

#### **Proposed Course Description:**

This studio course provides focused studio time to explore perceptual and conceptual approaches to drawing. Students will explore the use of various drawing materials and tools. Techniques will investigate methods to build hand-eye coordination and ways to use imagery as a base for creative exploration. Experimental and process-related approaches to drawing will be incorporated to expand students' understanding of what a drawing can be. Activities include working from still life, live models, inventive exploration, collaborative exercises, and engaging in historical and contemporary research. Discussions and individual/group critiques develop critical and analytical skills. The curriculum may include a variety of approaches including readings, artist presentations and field trips.

#### **Learning Objectives:**

- Develop perceptual and technical skills including composition, line, value, perspective, texture, touch, and surface
- Engage in a substantive exploration of life drawing methods and observational approaches

#### **Current Course Description:**

This studio course provides focused studio time for the development of a series of transformative and imaginative drawings. Students will engage with inventive methods of working, such as mapping, conceptual, and time-based approaches. They will utilize observation to prompt abstract artworks and installations. Students will experiment with media, techniques, and concepts that challenge dominant drawing practices. They will develop a stronger awareness of material possibilities and methods of working that respond to the senses. The course will include readings, artist presentations, field trips or other activities as forms of research.

#### **Proposed Course Description:**

This studio course provides focused studio time to explore approaches to drawing that navigate between observation, transformation, abstraction and imagination. Students will develop their drawing skills, explore materials, and learn of new techniques as they develop content and meaning through drawing processes. Students will compliment traditional drawing approaches with inventive methods. They will develop a stronger awareness of methods of working that respond to the senses. Over the duration of the course, projects and exercises are interconnected, each producing the groundwork for the next steps. Discussions and individual/group critiques develop critical and analytical skills. The curriculum will include a variety of approaches that may include readings, artist presentations and field trips

#### **Learning Objectives:**

#### **Technical and Material**

- Experiment with scale and site-responsive installations
- Explore unconventional materials, supports, and techniques
- Examine two-, three-, and four-dimensional approaches to drawing

#### Critical Inquiry

- Expand students' understanding of how iterative processes are a method for ideation and imagination
- · Build students' awareness of material cultures and concepts of embodied knowledge
- Experiment with non-traditional models of critique

#### Research and Professional Practice

- Synthesize strategies of ideation, iterative thinking, analysis, and sequential investigation through drawing
- Equip students to become flexible, adaptable, and creative problem solvers
- Gain experience with professional handling of critical aspects of a drawing practice including material use, exhibition, and documentation, as well as ongoing engagement with contemporary discourses, and visual, written, and oral presentation of work.

Situated within a basket of Indigenous values, this curriculum privileges Indigenous presence and the gifts that Indigenous cultures have contributed and continue to contribute to the social, ecological, cultural and political fabric of Vancouver, British Columbia and Canada. Through thematic based lessons, presentations, interviews, readings and films, we will trace important moments in Indigenous histories emphasizing the diversity of Indigenous peoples in Canada and North America. This course will also track the impacts of Indigenous-settler relations as they inform our current historical moment and aims at decolonizing our lenses and developing an understanding and validation of a plurality of knowledges and alternative histories. A central tenet of this course is understanding the spirit of place and the importance of the local, and the ways in which place informs us as artists, designers, guests and community members. By fore-fronting place and the land, we are situated, as teachers and learners, in a reciprocal, responsible relationship with the Indigenous ethos of "all my relations."

#### **Proposed Course Description:**

This foundational course (open to all levels) introduces students to Indigenous peoples, worldviews, cultures, and ways of knowing through the lens of contemporary Indigenous artists and their cultural expressions. Situated within a basket of Indigenous values, this curriculum privileges Indigenous presence and the gifts that Indigenous cultures have contributed and continue to contribute to the social, ecological, cultural and political fabric of Vancouver, British Columbia and Canada. Through thematic based lessons, presentations, interviews, readings and films, we will trace important moments in Indigenous histories emphasizing the diversity of Indigenous peoples in Canada and North America. This course will also track the impacts of Indigenous-settler relations as they inform our current historical moment and aims at decolonizing our lenses and developing an understanding and validation of a plurality of

knowledges and alternative histories. A central tenet of this course is understanding the spirit of place and the importance of the local, and the ways in which place informs us as artists, designers, guests and community members. By fore-fronting place and the land, we are situated, as teachers and learners, in a reciprocal, responsible relationship with the Indigenous ethos of "all my relations." An integral part of this course will teach Indigenous values through Indigenous material workshops that may include beading, brush-making and working with natural ochres. This course may also include field trips on the land and attending local Indigenous cultural events like powwows or Hoobiyee (New Year Festivals). All students welcome.

#### Chair's Summary:

The Senate Governance Committee has been working on the following:

#### 1. A Review of Senate Budget Committee

The University Secretariat's office is conducting research on the structure and practices of Senate Budget Committees at other post-secondary institutions. The hope is that the research will help to inform ways to enhance ECU's practices and potential recommendations for change to the Senate. In addition, the motion that was brought forward at the April Senate meeting by Senator A. Phillips with a recommendation on the meeting sequencing for the Senate Budget Committee was noted and will be included as part of the review that is underway.

#### 2. Senate Committee Operating Guidelines

The Committee undertook a final review of a draft policy document that established a common set of operating principles for Senate Committee operations. There have been at least two rounds of review of the draft and that the goal is to bring this forward for the fall. As part of this work, there was a question about whether observers are permitted to attend Senate Committee meetings. It was agreed that further research would be conducted on the practices at other post-secondary institutions and will be brought back to the Committee.

#### 3. Draft Senate and Senate Committee Resource Guide

The Committee is also reviewing a resource guide that has been developed for Senate Committee members and chairs. The goal is to bring the resources forward for the fall.

#### 4. Information Requests

A new item that will be picked up by the Senate Governance Committee is to consider practices and guidelines on making/responding to information requests from Senate/Senators. The University Secretariat will support this work.

#### MDM Graduation Requirements – Effective September 01, 2012

The following document outlines the degree requirements for the Master of Digital Media degree, jointly credentialed by UBC, SFU, ECU and BCIT. These requirements were passed by the Senates at UBC, SFU, and ECU and by the Education Council at BCIT. The MDM degree is accredited by the Degree Quality Assessment Board of British Columbia.

**Required Courses:** All required courses are graded based on a 4.33 scale

- [DMED 522] Projects III (12 credits)
- [DMED 530/531] Internship (6 credits) Although required, the internship is not graded, it is marked as complete/incomplete/in progress

**Electives:** Electives may be taken at the partner institutions or be drawn from the special topics offered on-site at the GNWC. Elective courses are graded based on a 4.33 scale. Students are required to complete 3 elective credits.
